

City-Bay Fun Run 2026

Run for Free Fundraiser Incentive Terms and Conditions

1. Instructions on how to enter and other details contained within promotional advertisements for this promotion form part of the conditions of entry. Taking part in this promotion constitutes acceptance of these terms and conditions.
2. The promoter is City Bay Fun Run Committee Incorporated ABN 62 163 898 527, PO Box 10080, Adelaide BC 5000 (Promoter).
3. This promotion commences at 5.00 AM ACST on Wednesday 18 February 2026 and closes at 11.59 PM ACST on Sunday 20 September 2026, being the day of the City-Bay Fun Run 2026 event (Promotional Period).
4. Entry is only open to all City-Bay Fun Run 2026 registered participants (during the Promotional Period) who enter the promotion per the entry criteria (Eligible Entrants).
5. To enter, Eligible Entrants must: a. Register to participate in the City-Bay Fun Run 2026 event during the Promotional Period, create a fundraising page on the Grassrootz fundraising platform, raise a minimum of AUD \$1,000.00 for their chosen charity on their Grassrootz fundraising page, and be among the first 100 eligible fundraisers to submit a completed claim/rebate form.
6. There is a limit of one (1) entry per person.
7. The promotion is limited to the first 100 Eligible Entrants who meet all entry criteria and successfully submit a completed claim/rebate form during the Promotional Period. Once 100 valid claims have been received, the promotion will be closed and no further claims will be accepted.
8. Eligible Entrants who successfully meet all entry criteria will receive a refund of their City-Bay Fun Run 2026 entry fee, minus the Race Roster registration fee, credited back to their original payment method within a reasonable timeframe following the event day and verification of their claim.
9. Eligible Entrants will be notified by email within two (2) business days of their claim being verified and approved.
10. The Promoter's decision regarding eligibility and claim verification is final, and no correspondence will be entered into.
11. Eligible Entrants must provide the Promoter with the details of their Grassrootz fundraising page for the rebate to be fulfilled. Reaching the \$1,000 fundraising milestone does not result in an automatic refund; it is entirely at the discretion of the fundraiser whether they choose to proceed with submitting the rebate claim form.
12. Upon reaching the \$1,000 fundraising milestone on their Grassrootz fundraising page, Eligible Entrants will be sent a rebate claim form via email. Once 100 fundraisers have submitted a valid claim, the rebate form link will no longer be distributed to fundraisers who subsequently reach the \$1,000 milestone.
